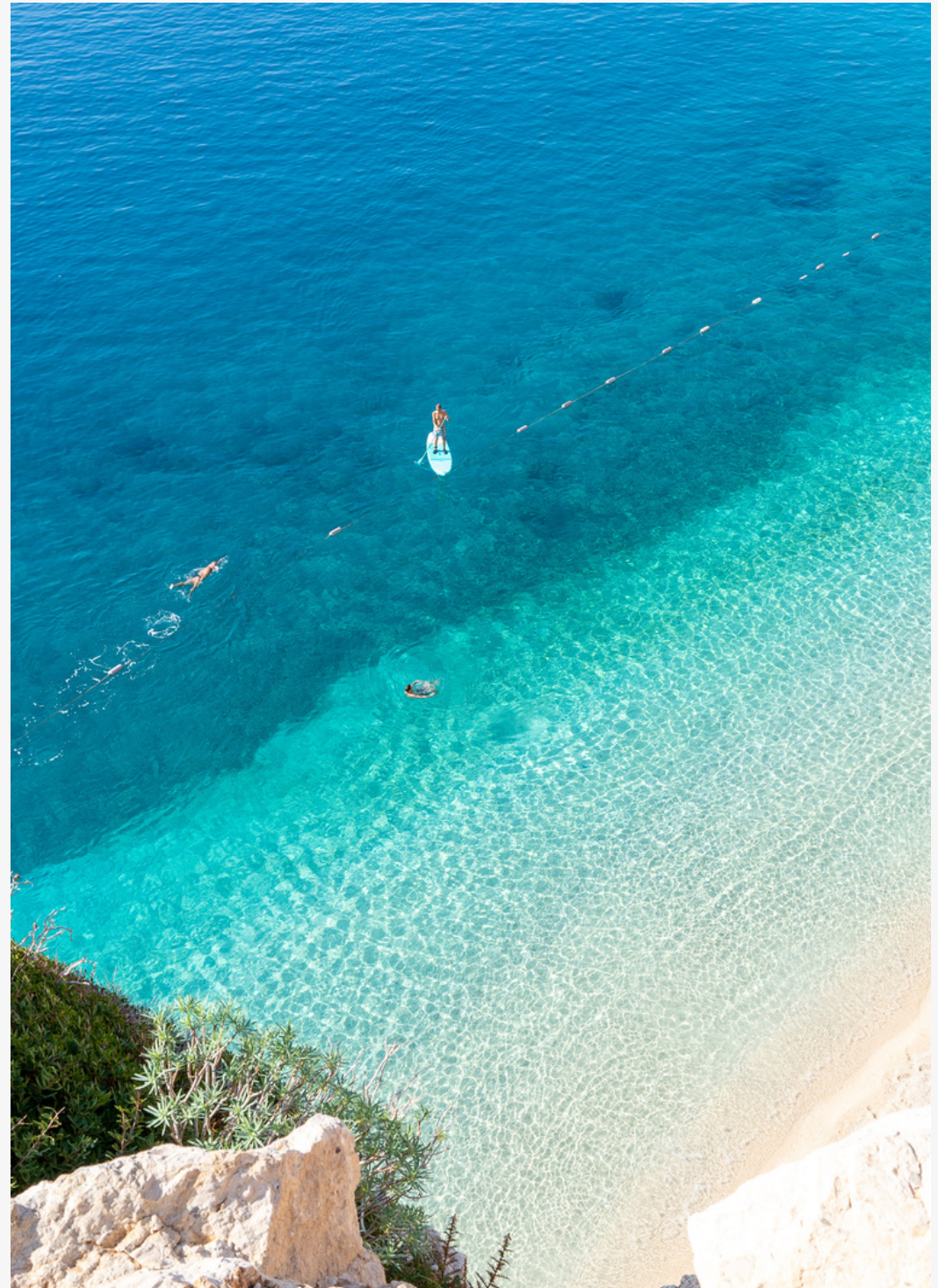

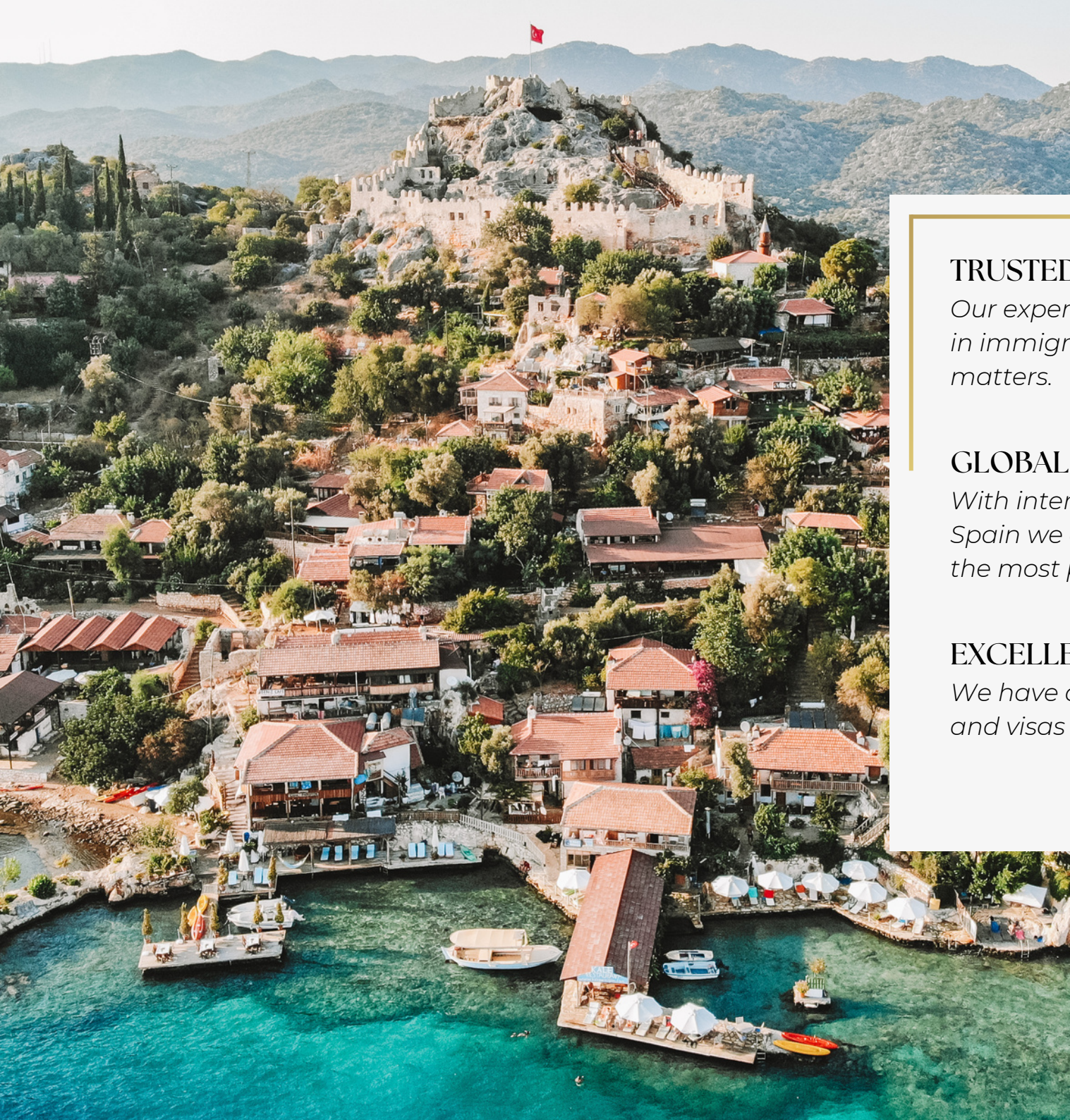




PROGRAMME
